Growing Up With Media – New Recruitment Study Wave 1

Prepared by Princeton Survey Research Associates International for the Center for Innovative Public Health Research

January 2017

Summary

The "Growing Up With Media" New Recruitment study, sponsored by the Center for Innovative Public Health Research (CiPHR) and the National Institutes of Health (NIH), is a study of U.S. parents and their children.-Survey results are based on a nationally representative sample of matched pairs of parents/legal guardians and their children ages 14-15. Parents were recruited via landline and cellular telephones. Parents were interviewed briefly on the phone before their teen was interviewed. Teens completed a brief phone interview and were invited to finish the remainder of the survey online. Interviewing was conducted in English and Spanish.1 Telephone interviewing was administered by Princeton Data Source, LLC. Online interviewing was self-administered by respondents. The study was conducted under the direction of Princeton Survey Research Associates International (PSRAI).

This report documents sampling, data collection and weighting procedures for the New Recruitment survey.

Sample Design

Three separate samples were used to reach the target population by telephone. The first sample used was a combination of random digit dial (RDD) landline and cell sample. Both samples were provided by Survey Sampling International, LLC (SSI) according to PSRAI specifications. Numbers for the landline sample were drawn with equal probabilities from active blocks (area code + exchange + two-digit block number) that contained one or more residential directory listings. The cellular sample was not list-assisted, but was drawn through a systematic sampling from dedicated wireless 100-blocks and shared service 100-blocks with no directory-listed landline numbers.

Due to the challenges of contacting such a low incidence target population, we supplemented the main RDD sample with callback sample gathered from PSRAI Omnibus surveys. The Omnibus is a national general population survey of 1,000 interviews with adults age 18 or older that is usually fielded every other week. The Omnibus uses a dual-frame landline/cell RDD sample design that is identical to the design outlined above. Callbacks were conducted with people who said during the Omnibus interview that there was a child ages 12 to 17 in the household.

The last samples used were targeted listed samples provided by Marketing Systems Group (MSG).

The first listed sample was pulled from MSG's Consumer Cell Database, which is multi-sourced and comprised of cell, VoIP and cable information and is updated monthly. This cell phone data is not self-reported, but rather it is built from hundreds of sources including public records, phone directories, U.S. Census data, consumer surveys, and other proprietary sources which are in turn used to append a phone number to a record. The current universe of the database for one record per household is 58,410,381, which covers approximately 46.8% of the households in the U.S.

Demographic information on the consumer cell phone record, where available, comes with the ability to target demographics including but not limited to age, ethnicity, and education. With the ability to generate sample at the Census block level, this database is an ideal alternative for hard to reach, small geographic areas. The targeting capabilities provide a more productive sample that yields a higher working rate as well as an increased incidence on the demographics selected.

The second targeted sample was a listed sample of landline telephone numbers. MSG provides researchers with access to all available listed telephone households in the U.S. Listed household samples provide the ability to improve both sample efficiency and incidence rates. With targeted demographics available at the household level, MSG can provide samples of households with specific characteristics. Selection criteria include numerous demographic variables, including income, age and gender of adults and children, race, ethnic surnames, home ownership, etc. For this project, we selected households with children ages 11 to 15. This was the criterion that most closely matched our target population. The following table shows how much sample was used and the number of telephone completes that were generated in the recruitment effort for the online survey.

Data Collection

Contact Procedures

The New Recruitment survey was conducted from February 17, 2016 to October 23, 2016. Telephone interviewing started on February 17, 2016. The first web survey was completed on February 24, 2016. The last telephone interview was conducted on August 26, 2016, and the final web survey was completed on October 23, 2016.

As many as 7 attempts were made to contact and interview a parent at every sampled landline and cell phone number. After the parent interview, if a teen was not available, up to an additional 10 calls were made to interview an eligible teen. Sample was released for interviewing in replicates, which are representative subsamples of the larger sample. Using replicates to control the release of sample ensures

that complete call procedures are followed for the entire sample. Calls were staggered over times of day and days of the week to maximize the chance of contacting potential respondents. Each telephone number received at least one daytime call in an attempt to complete an interview.

Contact procedures for telephone interviews were slightly different for the landline and cell samples. For the landline samples, interviewers asked to speak with an adult household member. For the cell phone samples, interviewers first made sure that respondents were in a safe place to talk and that they were speaking with an adult. Calls made to minors were screened-out as ineligible. If the person was not in a safe place to talk, a callback was scheduled.

Interviewers then determined if the person on the phone was the parent or legal guardian of a minor and if the household had any 14 to 15-year-old residents. Households with no teens aged 14 to 15 were screened-out as ineligible. Those who were parents with an age-eligible teen in the household went on to complete the parent interview. If there was an age-eligible teen in the household and the person on the phone was not a parent of a minor, the interviewers asked to speak with the parent or guardian of the 14 to 15-year-old teen. If the parent was not available, a callback was scheduled.

In eligible households, interviewers first conducted a short parent interview with either the father/male guardian or mother/female guardian. Parents were asked whether they agreed to take the survey. Parents who did not consent were terminated. Parents who consented continued with the parent interview.2 The parent interview consisted of some basic questions, including household demographic questions and questions about a particular teen in the household (selected at random if more than one eligible teen lived in the household).

For both samples, after the parent interview was complete, a short interview was completed with the target teen. Before handing over the phone, parents who were interviewed in Spanish were asked if their child would prefer to take the survey in English or Spanish. Before starting the teen interview, interviewers asked teens if they were in a private space where they felt comfortable answering questions honestly. If teens answered no, a callback was scheduled. The teen telephone interview consisted of questions to collect basic demographics and contact information. At the end of the telephone interview, teens were told that the remainder of the survey could be completed online. Teens were offered a choice of receiving the survey link via email, text message, or both. Teens who provided an email address or cell phone number were sent an invitation with a personalized survey link via their preferred method, after the telephone survey was complete. If the teen did not provide an email address or cell phone number, they were thanked for their time and told they would not be contacted again about the survey.

Email and text invitations contained a unique survey link to access the online survey hosted by PSRAI. Interviewing progress was monitored regularly, and email and text reminders were sent throughout the interviewing period.

Teens were asked to enter their own contact information at the end of the survey. These data were captured and stored in a separate online survey instrument to ensure that personally identifiable information (PII) was not directly linked to survey responses.

On average, the online survey took teens about 44 minutes to complete. Teens who took the survey on a mobile device finished in about 46 minutes on average. Those who took the survey on a desktop or laptop computer finished in about 39 minutes on average.

Consent

At the start of the online survey, participants were given a description of the research as well as the incentive amount for completing the survey. Participants were asked to read an assent form. All participants were asked to indicate their willingness to participate in the survey, before continuing with the main survey.

Additionally, when participants were asked to provide their contact information in the PII (personally identifiable information) survey, they were notified that by doing so, they were agreeing that their contact information could be used:

- 1. By PSRAI to email a gift card for successful completion of the survey;
- 2. By PSRAI for the purposes of the survey (e.g., to send reminders or helpful information about how to finish the study if they didn't finish it); and
- 3. To contact the respondent for this project or future surveys, by CiPHR or a company engaged by them.

Control of the Sample and Incentives

To maintain the reliability and integrity of the sample, the following procedures were used for the New Recruitment survey:

- 1. <u>Personalized survey links</u>. Each email or text invitation sent to those who completed the telephone interview contained a personalized link for the main survey that was uniquely assigned to that email address or cell phone number. This ensures that a respondent completes the survey only one time.
- 2. <u>Email and text reminders</u>. To increase the number of participants in the online survey and to improve overall response rates, PSRAI sent email and text message reminders after the initial invitation to recruited teens who had not yet begun, completed or refused to participate in the survey (i.e., non-responders and suspends). Email and text message reminders were sent approximately every two weeks throughout the study. At the end of August, PSRAI transitioned these outreach efforts over to CiPHR, who then continued outreach via phone, email and text in September and October.
- 3. <u>Incentives</u>. To increase the number of participants in the survey and to improve overall response rates, teens were offered a \$20 Amazon gift card for completing the survey3.
- 1. <u>Teen "early responder" incentive</u>. To increase the speed and likelihood of completing the online survey, an extra \$5 was offered in the initial invitation for completing the survey within two days of receiving the survey link.

³ The incentive amount was increased from \$15 to \$20 in April.

- 2. <u>\$5 bonus incentive</u>. In a further effort to increase the response rate, participants who had not yet completed the survey in the last month of field were offered an extra \$5 if the online survey was completed by a specified date.
- 1. <u>Targeted follow-up for suspended interviews</u>. In an effort to increase the number of completed online interviews, CiPHR sent custom communications to suspended participants (i.e., those who started the online survey but stopped before completing). On a weekly basis through the end of April, PSRAI provided CiPHR with contact and survey status information for these participants. Starting in May, PSRAI took over all communications to suspended participants (see *Gentle reminder calls* below). At the end of August, CiPHR resumed outreach efforts to suspended respondents.
- 2. <u>Gentle reminder calls, texts and emails for non-responders and suspends</u>. From June through August, PSRAI called non-responders and suspended respondents to remind them about the survey. Calls were made to teens who finished the phone survey but did not start or complete the main online survey or the PII survey. If a parent answered the phone for these gentle reminder calls, interviewers asked if there was anything they could do to help ensure that the teen finished the online survey. Interviewers offered to send the survey link to the teen if the parent requested it. If the teen answered the phone, interviewers read a short reminder about the survey and offered to send the survey link if the teen requested it. If neither a parent or teen answered, a voicemail message was left with a reminder about the survey and a toll-free call back number if assistance was needed. Gentle reminders were administered on a regular basis for a six-week period following the completion of the initial telephone recruitment.
- 3. <u>Switch to Callback sample</u>. New recruitment interviewing was suspended on March 30, 2016 to review RDD sample performance and discuss alternatives to increase recruitment efforts. Following approval to switch from RDD sample to callback sample, interviewing using the callback-methodology resumed on May 23, 2016. Callback sample was generated from PSRAI Omnibus surveys that utilize RDD sampling methodologies. PSRAI also conducted scaled-down Omnibus surveys to generate additional callback for this study. Callback sample from PSRAI Omnibus surveys were introduced to New Recruitment interviewing after a minimum two-week period following the completion of the original Omnibus telephone interview.
- 4. <u>Additional efforts</u>. All participants who contacted PSRAI because of difficulty completing the survey were offered individualized troubleshooting assistance by the PSRAI team. Participants were contacted within one business day to uncover and resolve any issues.

Weighting

The New Cohort data was weighted in three steps. The first step involved weighting the full sample to match target population parameters. This step was done to produce parameters for the second weighting. The second step involved weighting the responders and non-responders to equivalence for the behavioral variable parameters derived from the initial full sample weighting. The third and final step of the weighting process involved weighting the full sample to population parameters using the weights derived from the equivalence weighting as a first-stage sample adjustment. Below are more detailed descriptions of the three weighting steps.

Population parameters came from an analysis of the American Community Survey (ACS) 2014 1-year PUMS files. The analysis was based on all parents who have at least one child ages 14 or 15 in their household. Parameter distributions are given in the next section.

Step 1: Weight full sample to produce behavioral variable parameters.

This weighting was accomplished in two stages. A first-stage weight was computed to account for different probabilities of selection based on the size of the samples and frames. The first-stage weight was computed independently for each of the three samples used.

For fresh RDD sample, the first stage of weighting corrected for different probabilities of selection associated with the number of adults in each household and each respondent's telephone usage patterns. This weighting also adjusts for the overlapping landline and cell sample frames and the relative sizes of each frame and each sample.

This first-stage weight for the case *i* can be expressed as:

For the RDD callback sample, we used the final weight from the original Omnibus survey as the first-stage weight for this weighting. The original survey weight was computed using a standard two stage process:

- 1. The first-stage weight was computed using the same method as outlined above for overlapping dual-frame sample designs.
- 2. The second stage weighted raked the sample demographics to match.

All telephone completes that came from the listed samples were assigned a first-stage weight of 1.0.

The second stage of weighting for the New Cohort was a raking of the total sample phone completes to match population parameters for the following marginal distributions.

Population parameters were based on an analysis of the American Community Survey (ACS) 2014 1-year PUMS data. This weighting was accomplished using SPSSINC RAKE, an SPSS extension module that simultaneously balances the distributions of all variables using the GENLOG procedure. The final weight for this step was truncated at the 3rd and 97th percentiles to ensure that individual cases did not have too much influence on survey results.

This weighting was used to produce behavioral population parameters used in subsequent weighting. The following four behavioral parameters were derived from the initial weighting and used for the equivalence weighting.

Step 2: Weighting to Equivalence on Behavioral Variables

The second weighting involved weighting responders and non-responders to equivalence on the four behavioral variables outlined above. The responders and non-responders were weighted separately so that the marginal distributions of the behavioral variables matched the targets. As with the initial weighting, this was accomplished using SPSSINC RAKE.

Step 3: Final Sample Weighting

The third and final step for the weighting involved raking the total sample to the nine population parameters used in the initial weighting. The weight derived in the second weighting was used as an input weight. This weighting was done twice – once for the full final telephone sample (n=303) and once including only cases that came from RDD samples (n=266). Both weights were truncated at the $3^{rd}/97^{th}$ percentiles and the $5^{th}/95^{th}$ percentiles.

Post-data collection statistical adjustments require analysis procedures that reflect departures from simple random sampling. PSRAI calculates the effects of these design features so that an appropriate adjustment can be incorporated into tests of statistical significance when using these data. The so-called "design effect" or *deff* represents the loss in statistical efficiency that results from unequal weights. PSRAI calculates the composite design effect for a sample of size n, with each case having a weight w_i , as:

$$deff = \frac{\sum_n {w_i}^2}{(\sum_n w_i)^2}$$

In a wide range of situations, the adjusted standard error of a statistic should be calculated by multiplying the usual formula by the square root of the design effect (V*deff*). Thus, the formula for computing the 95% confidence interval around a percentage is:

$$\hat{p} \pm \sqrt{deff} \times 1.96 \sqrt{\frac{\hat{p}(1-\hat{p})}{n}}$$

The survey's margin of error is the largest 95% confidence interval for any estimated proportion based on the total sample— the one around 50%. For example, the margin of error for the entire telephone sample is \pm 7.6 percentage points. This means that in 95 out every 100 samples drawn using the same methodology, estimated proportions based on the entire sample will be no more than 7.6 percentage points away from their true values in the population. It is important to remember that sampling fluctuations are only one possible source of error in a survey estimate. Other sources, such as respondent selection bias, questionnaire wording and reporting inaccuracy, may contribute additional error of

greater or lesser magnitude. The following table shows design effects and sampling errors for various weights that are in the dataset.
